

NOTICE FOR THE ATTRIBUTION OF ONE RESEARCH FELLOWSHIP (BI) TO A MASTER ENROLLED IN A NON-DEGREE COURSE TAUGHT BY A HIGHER EDUCATION INSTITUTION WITHIN THE PROJECT " PROTOCOLO UNIFICADO PARA O TRATAMENTO TRANSDIAGNÓSTICO DAS PERTURBAÇÕES EMOCIONAIS DAS CRIANÇAS (PU-C): ESTUDO MULTICÊNTRICO PARA AVALIAR A ACEITABILIDADE, VIABILIDADE E EFICÁCIA DA VERSÃO COMBINADA DO PROGRAMA EM PORTUGAL" (REF. One Research Fellowship (BI) for a master enrolled in a non-degree course taught by a higher education institution is available at Faculdade de Psicologia da Universidade de Lisboa (Faculty of Psychology, University of Lisbon), within the Project "Protocolo Unificado para o Tratamento Transdiagnóstico das Perturbações Emocionais das Crianças (Pu-C): Estudo Multicêntrico para Avaliar a Aceitabilidade, Viabilidade e Eficácia da Versão Combinada do Programa em Portugal" (REF. PTDC/PSI-GER/0689/2020), funded by pela Fundação para a Ciência e a Tecnologia, I.P. /MCTES by national funds (PIDDAC), with the following conditions:

A. Scientific Domain: Clinical and Health Psychology

## Mandatory admission criteria:

- 1. Master degree in Clinical and Health Psychology, with a minimum master's final grade of 16;
- 2. Registration and enrolment in a non-degree course taught by a higher education institution. This condition will be verified until the contract signing data;
- 3. Immediate availability.

In addition, the candidate enrolled in a non-degree course taught by a higher education institution must cumulatively fulfil the following requirements [Article 6 of the current FCT Regulation for Research Studentships and Fellowships (Regulation No. 950/2019, of December 16, altered by the Regulation No. 643/2021, of July 14)]:

• The fellowship holder does not exceed, with the celebration of the fellowship contract in question, including possible renewals, an accumulated period of two years in this type of fellowship, consecutively or interpolated. This will be verified through a declaration of honor sent by the candidate with the application.

# Warning: the candidates that do not fulfil the above criteria will be excluded. The condition determined in point 2 of the admission criteria will be verified until the date of signature of the contract.

## B. Preferential admission criteria:

- 1. Knowledge and experience in cognitive-behavioral psychological interventions for children;
- 2. Knowledge in the application and analysis of psychological assessment tools for children and adults, namely clinical interview;
- 3. Knowledge and experience of applied research in psychology in areas related to the targeted



activity of the scholarship;

4. Knowledge and experience of quantitative data analysis using statistical analysis software (e.g. IBM SPSS).

#### C. Plan of activities:

The successful candidate will be involved in activities to support the execution of project tasks, namely:

- a) Recruitment and selection of participants for the Randomized Controlled Trial;
- b) Application and analysis of psychological assessment instruments for children and adults (selfanswer questionnaires and clinical interviews);
- c) Collaboration in the conduct of the Randomized Controlled Trial, namely by conducting therapeutic groups of the combined version of the intervention program "Protocolo Unificado para o tratamento transdiagnóstico das perturbações emocionais das crianças";
- d) Entering data into databases;
- e) Collaboration in data analysis;
- f) Collaboration in the writing of scientific documents (e.g., reports, communications and scientific articles).

## D. Legislation and regulation:

Research Fellowship Holder Statute, approved by Law No. 40/2004, of August 18, altered by Decree-Law No. 202/2012, of August 27, by Decree-Law No. 233/2012, of October 29, by Law No. 12/2013, of January 29, by Decree-Law No. 89/2013, of July 9, and by Decree-Law No. 123/2019, of August 28; FCT Regulation for Research Studentships and Fellowships, published by the Regulation No. 950/2019, of December 16, and altered by the Regulation No. 643/2021, of July 14; Regulation of Research Fellowships of the University of Lisbon, published by Order No. 6238/2020, of June 12 and amended by Order No. 8061/2022, of July 1.

#### E. Place of research activities:

The research activities will take place at the Research Center for Psychological Science of the Faculdade de Psicologia da Universidade de Lisboa, as host institution. The fellowship holder will work under the supervision of Professor Ana Isabel Pereira.

## F. Studentship duration:

The fellowship will last for 12 months or until the end date of the project (March 28, 2024), scheduled to begin in March 2023.

## G. Monthly grant value:

The successful candidate will receive 1.144,64€ (one thousand one hundred and four euros and sixtyfour cents) gross per month, according to the FCT pay scale <u>https://www.fct.pt/apoios/bolsas/valores</u>, which are paid monthly by bank transfer. To this amount must be added the Voluntary Social Insurance, corresponding to the 1st step, if the candidate chooses to be allocated it, as well as the Personal Accident Insurance.

The activities will be developed under exclusive dedication, in accordance to the Article 5 of the Research Fellowship Holder Statute.



### H. Selection methods:

H.1. The selection method to apply will be the following: Curricular Evaluation (AC).

H.2. The **Curricular Evaluation** corresponds to the **Final Evaluation (AF)** will graduate from 0 (0,00 minimum scale) to 20 values (20,00 maximum scale), valued to the hundredths, according to the following formula: AF = 0.4 HA + 0.5 PCP + 0.1 ACPR.

a) Academic Qualifications (HA) will graduate from 10 to 20 values, according to the academic degrees that the candidates prove to hold, in the following terms:

Arithmetic average of the final grade of the Bachelor's Degree in Psychology and Master's Degree in Clinical and Health Psychology or final grade of the Integrated Masters in Clinical and Health Psychology, which will correspond to the candidate's final course grade.

The verification of this criteria will be based on the certificate of the degree.

b) The **Scientific and Professional Background** (PCP) will graduate from 0 to 20 points according to the nature of activities performed and previous experience in the area of insertion of activity for which the present notice was opened, as follows:

b.1. Knowledge and experience in cognitive-behavioral psychological interventions for children (8 points);

b.2. Knowledge in the application and analysis of psychological assessment tools for children and adults, namely clinical interview (5 points);

b.3. Knowledge and experience of applied research in psychology in areas related to the targeted activity of the scholarship, specifically child psychopathology and evidence based interventions with children and parents (5 points);

b.4. Knowledge and experience of quantitative data analysis using statistical analysis software (e.g. IBM SPSS) (2 points).

The verification of this criteria will be based on the analysis of the CV, certificates, letters of reference and/or scientific publications (or submitted to publication) indexed in international databases, i.e., Thomson Reuters, Web of Science or Scimago, Scopus.

c) The **Candidate's Suitability for the Required Profile (ACPR)** will graduate from 0 to 20 points according to the candidates' motivation and characteristics relevant to the activity of the scholarship.

The verification of this criteria will be based on the analysis of the motivation letter.



H.4. Candidates whose application is evaluated with a final classification of less than 14 points are not eligible for granting a research fellowship.

#### I. Selection panel:

The selection panel is composed by Prof. Ana Isabel Pereira, Associate Professor of the Faculdade de Psicologia da Universidade de Lisboa, as president of the selection panel; Professor Helena Moreira, Assistant Professor of the Faculdade de Psicologia de Ciências da Educação da Universidade de Coimbra, and Professor Carla Crespo, Associate Professor of the Faculdade de Psicologia da Universidade de Lisboa as effective members of the selection panel; and Professor Luísa Barros, Full Professor of the Faculdade de Psicologia da Universidade de Lisboa and Professor Margarida Custódio dos Santos, Invited Assistant Professor of the Faculdade de Psicologia da Universidade de Lisboa as alternate members.

### J. Communication of results:

All candidates will be ranked on the basis of their final score, and the order list will be published at the website of the Faculdade de Psicologia da Universidade de Lisboa, in <u>https://www.psicologia.ulisboa.pt/sobre/rh/bolsas/</u>, as well as, physically posted in their premises, at a visible and public place. Counting from the publication of the list, the candidates have 10 working days to make their claim regarding the results. The selected candidate will be notified via e-mail.

#### K. Application deadline and process:

The application period occurs from 10 to 24 February 2023.

The candidate should send the following documents:

- 2. Motivation letter;
- 3. Curriculum vitae;
- 4. Copy of certificate of the Bachelor's and Master's degree, or Integrated Master's, with the final grade;

Holders of academic degrees awarded by foreign higher education institutions must hold recognition of the academic degree required in this Notice in accordance with Decree-Law No. 66/2018, of August 16. The recognition of the degrees, in accordance with the paragraph above, must be obtained until the date of the contract agreement signature, if the candidate ranked in the eligible position obtained the academic degree required in this Notice abroad;

5. Copy of the proof of registration and enrollment in the study program or course required in this Notice, in the scientific areas identified in point A. Declaration of honor attesting that the candidate does not exceed, with the conclusion of the scholarship contract in question, including any renewals, an accumulated period of two years in this type of scholarship, consecutively or interpolated., available on <a href="https://www.psicologia.ulisboa.pt/sobre/rh/bolsas/">https://www.psicologia.ulisboa.pt/sobre/rh/bolsas/</a>, dully filled, if applicable;
- 8. Other elements that the candidate considers relevant to the application (e.g., reference letters; publications or papers submitted to publication with the certificate of submission).
